CALL TO ENTRY

The Oklahoma Art Guild is proud to offer this unique avenue for highlighting Oklahoma art to the national and international visitors that gather in Oklahoma City for the annual National Reining Horse Association Futurity. OAG is collaborating with the NRHA to present all types of Oklahoma art to this national and international group of highly successful competitors, owners, and business people. This gathering of equine enthusiasts adds \$18 million in direct spending and \$40.4 million in economic impact on Oklahoma during the 10-day competition at the Oklahoma State Fairgrounds. When walking through the barns and show arenas during the competition, you will hear a multitude of languages, ranging from English to French, German, Dutch, Spanish and Portuguese.

OAG's goal is to give all Oklahoma artists the opportunity to present their varied artistic talents to this unique gathering of individuals.

ELIGIBILITY:

- Submissions will be accepted from all Oklahoma artists 18 and over. You do not need to be an OAG member to submit.
- The jury will select all forms of Oklahoma art, inclusive of 2D and 3D works, Contemporary, Modern and Western art for this exhibition. By displaying a highly diverse pallet of art, we highlight the quality of life that Oklahoma offers along with fine Oklahoma art. Do not miss this unique opportunity to introduce your individual art to an audience that is truly appreciative of beauty!
- The jury panel will consist of four art professionals including an NRHA rep, an Oklahoma media rep, a member of the Oklahoma state arts community, and a representative of the OAG board of directors. All decisions of the panel are final. NO SUBSTITUTION of artwork from the original entry presented for the jury will be accepted.
